Concessionaires must provide their own security and insurance. Each Concession will receive one (1) weekend pass. Additional passes are available for \$25.

The Electrical Safety Code of Ontario requires that all electrical equipment must be approved before it may be lawfully advertised, displayed, offered for sale, sold or otherwise disposed of used in the Province of Ontario. It is therefore the responsibility of each exhibitor to ensure that all electrical equipment in, or about, their booth comply with the above regulations. This includes the electrical merchandise as well as lighting and display equipment. Should any of this equipment not conform, it is recommended that you request temporary permission to exhibit while the necessary approval certification is being sought. Please write directly to the appropriate inspection department for this area. Any questions concerning regulation for booth wiring should be addressed to the appropriate electrical supplier. Failure of Electrical equipment to comply with the safety code requirements can result in the equipment being refused connection to the source of electrical supply and it may even be ordered removed from the display.

All exhibitors/concessions are requested to comply with the Ontario Fire Code. Fire routes are not to be obstructed. Access to doorways and electrical panels are not to be obstructed. Appropriate extinguishers are to be maintained. Any combustible/hazardous items are to conform to the proper code and handled with the appropriate care.

All Food vendors must be in compliance with current Health & Safety Codes.

The SAS respects the privacy of its members, exhibitors, sponsors and volunteers. The information you provide will be used to maintain a membership database. Information from entries forms and/or photos/video may be used to create show catalogues and to publish show results in the newspapers and/or forwarded to the appropriate sponsors as specifically requested. Any member, exhibitor, commercial exhibitor, sponsor or director realizes that when they agree to take part in the Stormont Agricultural Society and the Stormont County Fair, that their names may be published for those reasons only. None of this information whatsoever will be sold or transferred to any outside party for any reason.
